THE HISTORY OF FLORIDA'S CAPITAL



Florida's Old and New Capitols

The unified government of Florida was established March 30, 1822, when President Monroe signed into law the act which provided for a Governor and a Legislative Council of 13 citizens.

Before 1823, the Legislature met alternately in Pensacola and St. Augustine. Traveling between the two cities took twenty days or more and was often hazardous.

In 1823, Mr. John Lee Williams of Pensacola and Dr. W. H. Simmons of St. Augustine were commissioned to find a permanent setting for the seat of government of the new Territory of Florida.

They met at a midpoint between the two cities and decided to place the territory's government near a waterfall with beautiful fields surrounding it.

Three log cabins were built to be used by the Legislative Council. The 1824 Council called the new town Tallahassee

The word "tallahassee" is of Creek derivation and is frequently translated as "old town" or "old fields." Page 2 Volume 1, Issue 1

SPECIAL SESSION JANUARY 5-16
