

## FY 2011-12 GENERAL APPROPRIATIONS ACT

The House passed a total state budget of \$69,676.6 billion, which is \$841.5 million less than last year's budget. General Revenue accounts for \$23,182.7 billion, which is \$863.3 million less than last year's budget. The FY 2011-12 spending plan will leave \$1 billion in general revenue fund reserves, \$492 million in the budget stabilization fund and \$789 million in the Lawton Chiles Endowment Fund for a total of \$2,281.0 million in reserves.

## FLORIDA ECONOMY

During the 2011 Legislative Session the Florida House passed numerous pieces of legislation aimed at fostering private sector job creation. This year, the Florida Legislature eliminated the corporate income tax for nearly half of the Florida businesses who currently pay it, created the Department of Economic Opportunity and State Economic Enhancement & Development (SEED) Trust Fund to consolidate economic development, workforce development, community planning and affordable housing initiatives, and modernized Florida's growth management system and unemployment compensation program.

Measures aimed to encourage private sector job creation include:

- <u>Corporate Income Tax Relief:</u> CS/HB 7185 increases the corporate income tax exemption from \$5000 to \$25,000.
- <u>Department of Economic Opportunity</u>: SB 2156 creates the Department of Economic Opportunity, which consolidates the Agency for Workforce Innovation, Department of Community Affairs, and the Office of Tourism, Trade and Economic Development
- <u>SEED Trust Fund</u>: HB 7205 creates the SEED Trust Fund within the Department of Economic Opportunity.
- <u>Growth Management</u>: CS/HB 7207 modernizes Florida's growth management system by removing layers of state oversight to give local governments control while focusing the state on important state resources and facilities.
- <u>Unemployment Compensation Tax Relief</u>: CS/CS/HB 7005 modernizes Florida's unemployment system and reduces taxes for most Florida businesses, providing businesses the financial security to continue to employ workers.

## 2012 LOCAL DELEGATION MEETINGS & REDISTRICTING



The House Redistricting Committee and the Senate Committee on Reapportionment plan to hold public meetings on redistricting for the Central Florida region between July 25-28. The public meeting schedule is also available at <a href="https://www.floridaredistricting.org">www.floridaredistricting.org</a>.

After holding public meetings on redistricting throughout the summer the 2012 Legislative Session will begin on **January 10, 2012** and end on **March 9, 2012**, at which time the new districts will be approved. Because session will begin earlier this year all local delegation meetings will be scheduled earlier. Depending on the start of committee meetings the Indian River County Delegation meeting will take place in late August or early September this year.
